1. Sample size. Describe how fish were selected i.e. from field or landing sites. This needs to be considered in some detail in the method.

2. Results. Could you provide some more details on the information provided by the range. For example, mean+/- SD with associated n.

3. References. I have added a few key references as examples. Do not feel exhaustive to add a few more to improve the quality and strengthen the manuscript.


4. Proof read. I have recommended some suggestions for wording in terms of spelling and grammar.

Line 69: Describe how samples were selected from the collection as it is said samples in this line. Were all collected individuals treated as samples? Line 75: This sentence indicates that no samples selection. Did survey team collect samples every day in the landing site? Describe frequency of fish collected at landing site in Pabean bay in monthly basis as there is a date in each graph presented in Figure 2.

#### 2. The current results and discussion

Line 147-148: Define as the current statement is a general one.

lines 149-151 are not well-explained. Link it with first recruitment and the size of the 1st time caught. This needs to be considered in some detail in the discussion and conclusion based on the results.

3. Proof read. I have edited many incorrect grammatical errors and provided some suggestions for wording.

2. Materials and Methods

Line 67: Describe in brief how sero and gill nets were used in sampling effort. How many fishers were assigned to sampling in each sampling station? Were numbers and fishers the same in each month?

Line 67-68: Why authors did not test size variation among three sample stations to assess whether their sampling efforts are representative?

3. The current results and discussion

Line 109: Describe in the method section how sampling dates were selected: Purposively or just random? Lines 150: Understandable for same pattern but authors are welcome to elaborate and strengthen it in relation to time as well.
