"My report is brief. The paper is interesting but fails short in two ways. First the authors need to solidly figure out why the paper is a fit to Information Systems Frontiers. (which means they have to clearly articulate the "information" aspect of the paper) Second, it is important to be able to figure out the effectiveness of the application. I know the authors have interviewed an expert - but with all answers being Yes, it raises the question if there is bias.

I think what is needed is a mechanism of unbiased evaluation that can be administered not only to one expert but to any other experts. Such a mechanism could be a semi-structured survey or a formal survey. Then they need to actually administer with one other expert - the idea is similar to getting interrater reliability. Note - I am not asking you to do another case study which of course is the ideal for generalizability.

Please note that this journal is a Transformative Journal (TJ).
